Welcome

History

In 1945, a small group of St. Simons residents gathered for weekly prayer services in their homes. The Rev. Thomas L. Harnsberger, minister of the First Presbyterian Church in Brunswick, led the prayer services. St. Simons Presbyterian Church (SSPC) was officially organized in 1946 with forty-six members. The church met in local public buildings until it dedicated its own building in 1954. It added space for Sunday classes in 1956. During the 1980s and 1990s the church grew in numbers, facilities and programs. In 1984 it dedicated a new fellowship hall with a kitchen, choir rehearsal room, additional classrooms, a large multi-purpose recreation room and an enlarged sanctuary. In 2007, SSPC completed a new children and youth building with Sunday School and activity rooms as well as a new administrative building containing staff offices and meeting spaces. We are now in the process of completing a successful capital campaign in support of a renovation of our sanctuary space that will begin later in 2019.

Today, St. Simons Presbyterian is a family of faith made up of people who come from all walks of life. We are active both in our fellowship and learning as well as in our service to the world around us. Among the many local mission activities of the church are our bi-annual "Day of Service," BRIDGE Mission Program, Hunger Action Team, and serving neighbors each month at Manna House. We also support numerous agencies in our community, PCUSA mission co-workers around the globe, and Presbyterian institutions through benevolent giving. The St. Simons Presbyterian Preschool, which opened its doors in 1983, is also a vibrant outreach ministry of the church that welcomes nearly ninety children onto our campus every day. Since our founding, we have been blessed by wonderful pastors and lay leaders who have and continue to guide us in our efforts to serve others and live out our mission to be "a people who celebrate God!"

From the St. Mary's / Jacksonville areas:

Follow I-95 North to the first Brunswick exit. (Exit 29). At the end of the ramp, turn right (North) on US 17, follow it across the Sidney Lanier Bridge into Brunswick and proceed to the St. Simons/Sea Island Causeway (F.J. Torras Causeway). Turn right onto the causeway and proceed to the **first** traffic light on St. Simons Island. At this intersection, turn right and proceed to the flashing light and stop sign at King's Way. Turn left and follow King's Way for approximately 1.5 miles. The church is on the left side of the street, just past the airport.

From the Savannah / Hinesville areas:

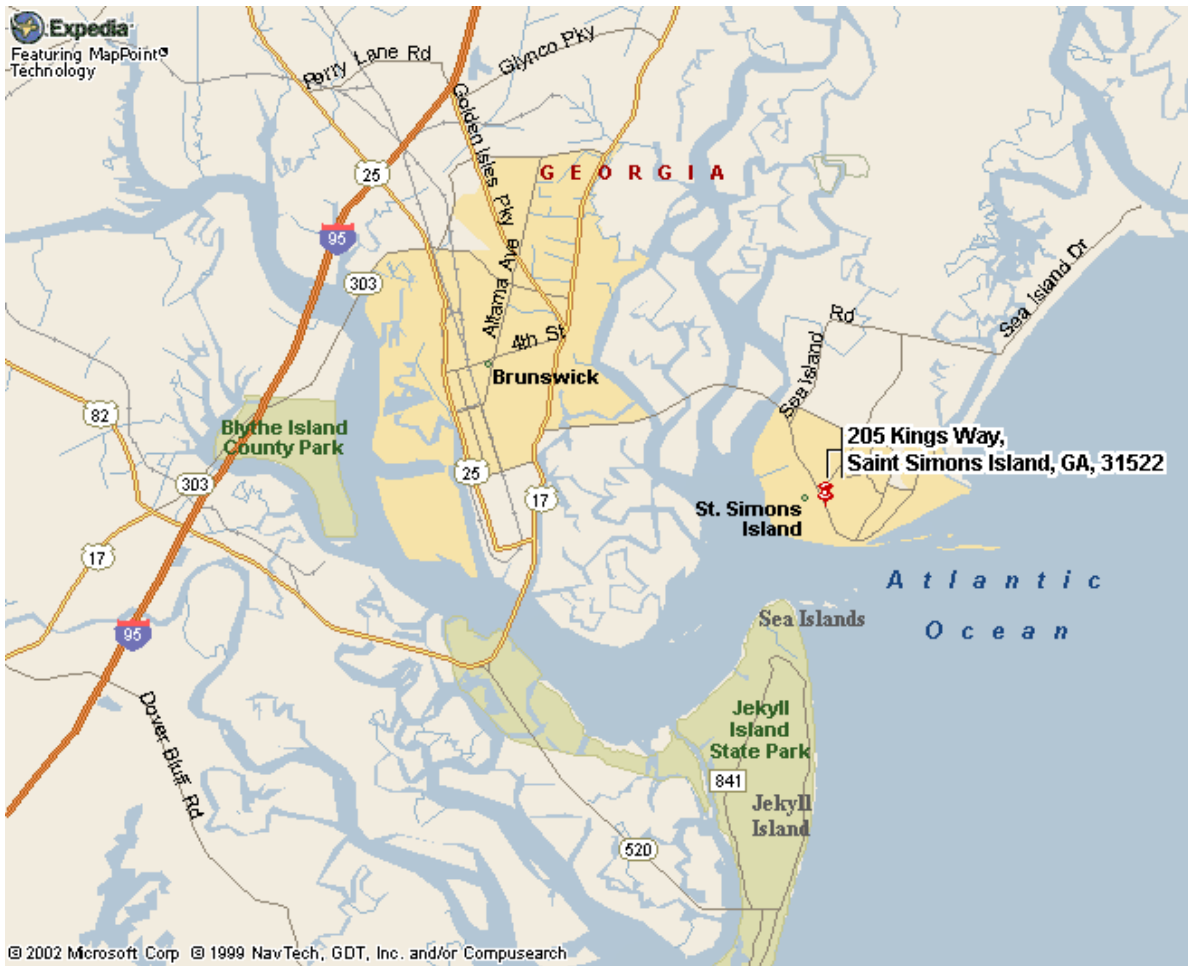
Follow I-95 South to the first Brunswick exit. (Exit 38). At the end of the ramp, turn left onto Golden Isles Parkway (GA Spur 25). Follow GA Spur 25 until it merges with US 17 South and continue on US 17 South to the St. Simons/ Sea Island Causeway (F. J. Torras Causeway). Turn left onto the causeway and proceed to the **first** traffic light on St. Simons Island. At this intersection, turn right and proceed to the flashing light and stop sign at King's Way. Turn left and follow King's Way for approximately 1.5 miles. The church is on the left side of the street, just past the airport.

From the Eastman / McRae / Jesup areas:

Follow US 341 South to Brunswick. Continue on US 341 South to Gloucester Street. Turn left on Gloucester Street and proceed to US 17. Turn left on US 17 (North) and get in the right lane. Continue about 200 feet to the St. Simons/ Sea Island Causeway (F. J. Torras Causeway). Turn right onto the causeway and proceed to the **first** traffic light on St. Simons Island. At this intersection, turn right and proceed to the flashing light and stop sign at King's Way. Turn left and follow King's Way for approximately 1.5 miles. The church is on the left side of the street, just past the airport.

From the Douglas / Waycross areas:

Follow US 82 to Brunswick. At Brunswick, US 82 will merge with US 17. Continue on US 17 North, follow it across the Sidney Lanier Bridge into Brunswick and proceed to the St. Simons/Sea Island Causeway (F.J. Torras Causeway). Turn right onto the causeway and proceed to the **first** traffic light on St. Simons Island. At this intersection, turn right and proceed to the flashing light and stop sign at King's Way. Turn left and follow King's Way for approximately 1.5 miles. The church is on the left side of the street, just past the airport.

Information:

- Today we will be voting on the proposed Amendments to The Book of Order. We have allotted a half an hour for this discussion and voting on these amendments. All members and Commissioners were given the Amendments to study at the October 23, 2018 Stated Meeting. We also sent another copy of the Amendments and a copy of the analysis work done by the Association of Stated Clerks to Pastors and Clerks to help you be prepared. To that end any discussion shall rotate back and forth between pro and con positions, and no one person speak on any amendment more than once. Unless otherwise requested we will vote by a show of hands. A simple majority of the votes cast will determine whether the presbytery is for or against any amendment.
- All clerks of Sessions are advised that the deadline for Annual Church Statistics was February 14, 2019. You may send your information to the Stated Clerk, and I will try to input it. The system has changed so I am not sure this can happen.
- Pastors and Clerks are notified that Pastor Terms of Call for 2019, including any changes in the terms, are due on or before the May21,2019 Stated meeting. They should be sent to the Stated Clerk. There are no exceptions to this. These documents are not published but are used by the Committee on Ministry and the GP/SC to ensure guidelines for salary are being observed and pastors are being fairly compensated.
- All churches need to send documentation of Liability Insurance on your property by May 21, 2019.
- We welcome the following guests to our meeting today, Rev. Joyce Lieberman, Exec/ Stated Clerk of the Synod of South Atlantic; Ruling Elder David York from the Presbytery of Greater Atlanta; Jerry Dean Webber, Presbyterian Homes of Georgia; and Sherri Bozardt, Thornwell.

Report of the Treasurer CRE Russell Gladding

There is some good news for the Presbytery in the final financial statements from 2018. Thanks to the faithful giving of our churches, we increased our giving by \$13,248.00 in 2018 over 2017. That increase triggered an additional matching by an anonymous donor equaling \$13,248.00. This added income of \$26,496.00 allowed us to close the gap of our deficits from the recent past. These deficits had been in the <\$40,000 to \$50,000> range in the last several years. In 2018 our deficit was <\$27,126.63>. Many thanks to all our pastors, sessions, and congregations for your faithful support.

One negative in this report is that we still have churches that do not pledge or give to Savannah Presbytery. This is disappointing and is not Presbyterian. Ours is a connectional church, and the ministries across southeast Georgia that Savannah Presbytery sponsors and supports, in my view, are part of our responsibility as Presbyters in this time and place. I urge and pray that every session will consider, and reconsider, being a part of the continuing ministry that is the 35 churches in Savannah Presbytery.

The Presbytery voted at our October Stated Meeting to continue to use the 2018 budget as our guide as we seek God's guidance in transforming us in a time of transition. Today you will hear the beginning plans for this transition. During the time of transition, we will continue our operation of Savannah Presbytery and its programs.

There will certainly be some financial changes in the course of 2019. The Savannah Presbytery Council will keep you updated as we seek to "hold on to what is good," and to be good stewards of the resources God provides us.

For Information:

Over the past several years the Council has been engaged in a discussion as to the future direction/mission of Savannah Presbytery. This discussion has come out of the recognition that our Presbytery – and our culture – is different now than it was even a few years ago, and that it will continue to change in the future. One of the changes that will soon have an impact is that our current General Presbyter/Stated Clerk/Treasurer, Russell Gladding, will likely be pursuing other ministry options sometime later this year.

Out of this discussion came the formation of the *2020 Task Force* that was tasked with engaging the Presbytery in looking at questions such as: *Who are we as Savannah Presbytery? What are we about? Where is God leading Savannah Presbytery?* Task Force Chairs, Alan Dyer and Ben Beasley, presented their report to the Council, and they will present their report at the February Stated Presbytery Meeting. Following their report, there will be break-out sessions to foster additional conversations and to garner constructive feedback.

While there was much in the report that the Council supported unanimously and enthusiastically, one area in which the Council was unable to reach a consensus had to do with future staffing of our Presbytery. Last fall, the Council decided the best course of action was to pursue an outside consultant to help the Council continue to look at our Presbytery and its staffing needs. The Council had conversations with two qualified candidates, and in the end hired David York. David has worked with Savannah Presbytery on several occasions over the years and has worked with many of our churches through Holy Cow Consulting. He will be present with us at our February Stated Meeting and will meet with the Council before the Faith Enrichment Conference kicks off.

The Council will continue to keep the Presbytery informed of its deliberations and decisions, and we hope to have recommendations ready for the Presbytery to consider at an upcoming meeting this year.

Other items of information

- Council approved using New Covenant Funds to pay our 2018 *Per Capita* for the Synod and General Assembly
- Council approved stipends to be paid to directors/coordinators of our Faith Enrichment Conference, Summer Camp and School of the Laity programs in 2019.

For Action by the Presbytery:

The Committee on Ministry recommends that Savannah Presbytery grant the Committee on Ministry the authority to act on the Presbytery's behalf in oversight of minister members and churches between meetings of the Presbytery when it is prudent to do so. Oversight shall include the ability to dissolve pastoral relationships, dismiss minister members or change the status of minister members. All such actions shall be reported at the next Presbytery meeting.

Approved

Rationale:

According to the Book of Order, G-3.0307, final paragraph, the presbytery...

"may delegate its authority to designated entities" including "its oversight of minister of the Word and Sacrament members including dissolution of relationships."

"All actions carried out as a result of delegated authority must be reported to the presbytery at its next regular meeting."

And according to Savannah Presbytery's manual, 19.2, the Committee on Ministry is responsible for... "dissolving pastoral relationships with a church" and "fulfilling responsibilities of G-3.03, which deal with transferring, examining, dissolving pastoral relationships, granting permission for laboring within or outside the bounds, and dismissing Teaching Elders. *Presbytery must annually grant this authority, ordinarily at the winter meeting.* (emphasis added).

Information:

- COM is reviewing Savannah Presbytery's "*Minimum Compensation Standards for Ministers*" which have not been updated since 2014.
- First Presbyterian Church, Douglas, Vidalia Presbyterian Church and First Presbyterian Church, Darien are actively circulating their Ministry Information Forms as each seeks its next pastor.
- In Savannah Presbytery, we have:
 - 17 churches being served by an installed pastor

Committee on Preparation for Ministry

Information:

The Committee on Preparation for Ministry met in-person in January 2019. At present, CPM of Savannah Presbytery has one active candidate for ministry under its care. Ruling Elder Russell Gladding has completed online coursework including a Hebrew language course, engaged in independent study under the guidance of the CPM, and completed one unit of Clinical Pastoral Education (CPE) at Memorial Health in Savannah. As of January, he has passed four of the five standard ordination exams. Upon passing the fifth required ordination exam, he will meet with the CPM for final assessment and certification ready to receive a call. Please continue to be in prayer for Russell.

CPM has also begun conversation with a ruling elder in Savannah Presbytery who is discerning a call to serve as a Commissioned Ruling Elder.

Lastly, CPM is beginning to implement a transition plan for members completing service on the committee. Specifically, Rev. Rachel Greiner and Rev. Alan Dyer have each served 5+ years on the committee and are requesting to step down for a time beginning this summer. Rev. Jeff Garrison will assume responsibility as chair beginning in June 2019. Additionally, Rev. Annie Franklin Arvin has agreed to join the CPM at the same time. CPM members are also actively searching for at least two additional lay members to join the committee.

Discipleship & Education Training Ministry Team

During the last four months, the Education Team has accomplished a great deal. The first Family Camp Connect was successfully conducted. Planning for the Savannah Presbytery Summer Camp has begun. The Faith Enrichment Conference, formerly the Leadership Development Conference, has been planned to celebrate the 40th anniversary of the conference and its rebranding.

Family Camp Connect, winter camp, was designed to give families insight into the Summer Camp experience that would encourage them to attend the Summer Camp, spread the word about camp, and affirm that being and growing in Christ includes having fun. The camp was divided into two age groups. The youngest group of campers had 18 people, ranging from 2 years old to 6th grade (each camper was accompanied by an adult). There were 13 youth campers.

History of School of the Laity

In the fall of 1988, ten laypeople of Savannah Presbytery became the first graduating class of an innovative presbytery ministry known as the School of the Laity. A very demanding program of study requiring a two-year commitment and additional hours of class and preparation time, the School of the Laity was a vision of then Executive Presbyter Dr. J. Richard Bass, who saw the desire of laypersons to engage in serious study of scripture, theology, and ministry.

The students participate in two summer courses taught by college professors. Each session involves eighteen hours of class time and additional hours of personal study. The courses are: Introduction to the Bible and Introduction to Reformed Theology. In the final summer, they complete their studies with an in-depth course in Practical Ministry.

Students complete brief courses in the spring and fall of two successive years. Savannah Presbytery ministers lead studies on Old Testament, New Testament, History, Mission & Polity and Practical Ministry 1. To date, over 250 laypeople have participated in the School of the Laity, representing two-thirds of the churches of the presbytery. Its graduates are providing outstanding leadership in their congregations, the presbytery and the Presbyterian Church, U.S.A.
