Welcome

Welcome to Skidaway Island Presbyterian Church. It is our vision to reflect the face of Jesus to the world. This congregation is generous in supporting local and foreign missions. Over the past year, we have funded the building of two tiny houses for homeless veterans and are currently participating with Habitat for Humanity in a faith build in Garden City. We hold a yearly fundraiser for Safe Shelter, a local women's shelter that raised over \$16,000 last year. We support the Savannah Early Childhood Foundation and several homeless missions through our giving and the involvement of our membership. A group of women meet on Monday afternoon to bake muffins for Emmaus House. Many of our members have participated in Faith in Practice trips to Guatemala and we support missions in Costa Rica and Indonesia. Our congregation has been generous in giving to the Presbyterian Disaster Assistance the past two years for hurricane relief. We are an aging congregation, but we are still finding ways to be involved in Christ's mission.

Worship is an important part of our common life at SIPC. We recently upgraded our sanctuary to help us better provide multi-media experiences in worship. We also have cameras and in addition to recording the worship service, we stream our services. Many of our members when away, as well as our shut-ins, watch the service on Sunday morning and are able to still feel a part of the congregation. We are also experimenting with worship styles that deepen our worship experience and help us praise God in new ways.

SIPC was the first congregation established on Skidaway Island. At the time the Rev. Charlie Shedd began gathering the church, which met in the firehouse, there were only about 100 homes on the island. Today, the island has a population of over 8,000 people. When our current property was purchased for a church, this island community was still in the dream stage. Thanks to the foresight of the Savannah Presbytery, and the seeding of members from both First and Independent Presbyterian Churches, Skidaway Island Community Church was established 41 years ago and has, since, been involved in Christ's mission. In 1994, as other denominations began to establish congregations on the island, we changed our name to Skidaway Island Presbyterian Church.

I am humbled to be called as Pastor of this church and I welcome all of you from the Savannah Presbytery and representatives from the Synod of the South Atlantic as we meet as a presbytery and worship and honor Russell Gladding for his service.

Special Reports

Report of the General Presbyter CRE Russell Gladding

It has been nearly twelve years, and there have been many wonderful memories, and a few that aren't so wonderful. But as Joseph Small writes in his new book, Flawed Church, Faithful God, "That is the Church we all deal with, and that God deals with." This has been an experience I will always treasure. As I leave this position of General Presbyter/Stated Clerk/Treasurer (I am not retiring!), I will always keep the people of Savannah Presbytery in my thoughts and prayers.

I consider you friends and colleagues in ministry. Suffice it to say, for all the times you smiled with me, laughed loudly, ministered to and with me, gave wise counsel to me, cried with me, and rejoiced with what God was doing in this place, I am grateful to God for your generous, loving spirits!

There are things that I have mentioned in my exit interview that I hope will be helpful as you chart a new course. I will mention only one of these items, as I feel strongly about it.

In 2011 at the Spring Meeting at Richmond Hill Presbyterian Church, I was commissioned to the position as your General Presbyter in addition to Stated Clerk and Treasurer. I preached a sermon that day titled, "Sailing with Little Faith." The text was Matthew 8 where Jesus says, "Oh you of little faith..." Using the Rev. Dr. Joan Gray's words and our churches as sailboats, I spoke of our need to help the smaller boats sail on, sometimes towing them or lashing them together. I spoke of those boats marooned along the shore, unable to sail. I spoke of the wind of the spirit that was blowing us and moving us in our ministry together.

Friends, we have the same, or perhaps much greater, challenge today as I leave you. We are also blessed to have significant financial resources which, in my opinion, need to be put to work for the sake of our smaller member congregations. We, Savannah Presbytery, who have much, bear much responsibility. This is not some Pollyanna thought, and it needs a good plan of how to renew our smaller congregations who, most of all, need pastors to guide them, possibly as yoked congregations or clustered in shared ministry together.

Friends, there is over one million dollars in our New Covenant Growth Fund, and it can be wisely used and sustained at a level to be there for a rainy day. Not to use this resource would be to the detriment of the Presbytery. I personally believe it is wrong to hold onto that whole amount when a program of revitalization grants could perhaps revitalize small Savannah Presbytery congregations.

So, I leave you with that challenge. May God's spirit blow where it will. May Savannah Presbytery continue to sail on together in faith.

Amen and amen!

Report of the Stated Clerk CRE Russell Gladding

The minutes of Savannah Presbytery for 2017 were approved without exception by the Synod of South Atlantic. Minutes for 2018 will need to be combined and numbered consecutively. The new Stated Clerk will need to make provisions for their reading. These are now done electronically. See Joyce Lieberman for further instructions.

Report of the Treasurer CRE Russell Gladding

The Balance Sheet through the first quarter of 2019 show that the Presbytery is solid in its Current Ratio. All bills are paid and current.

It is appropriate to state that the giving of several churches appears as if they have cut back on their pledge for 2019. While in this transition our only benchmark is the 2018 budget. It will be important that the Council and Stewardship and Finance Team get an early start, perhaps August on planning for next year's budget. The Sessions of our congregations should be asked to submit their pledges by early fall in order to have a budget to propose at the October 2019 Stated Meeting.

The Income and Expense Statement shows through March, 2019, a surplus income of nearly \$26,000. That is in part due to a smaller deficit in 2018, thanks to the anonymous matching gift we received.

We were able to pay our 2018 Per Capita to the Synod and General Assembly using funds from the New Covenant Growth fund. That is also part of the reason for our current surplus.

It is important that continued oversight of this year's financial operation be done by appropriate designees during the transition. It is also important that our congregations do their best to pay their pledges and gifts monthly as we move into the summer months.

Finance & Stewardship Committee RE Paul Scott

The review of the Financial Statements of Savannah Presbytery has been completed. Recommendations from the Audit Team will be published and placed in the Minutes of this Stated Meeting.

- That Russell Gladding's commission as a Commissioned Ruling Elder (CRE) to serve our presbytery as General Presbyter, Stated Clerk and Treasurer be dissolved on May 31, 2019.
- That Russell Gladding receive a severance package of up to six months of salary, housing, self-employment taxes and Board of Pensions' benefits that would conclude on November 30, 2019 or when he begins a pastoral call to serve a church, whichever comes first. This will be paid for out of the Presbytery's New Covenant Fund holdings.

Rationale:

Russell has served Savannah Presbytery faithfully in many capacities since 2007, including becoming our General Presbyter in 2011. His leadership, wise council and pastoral presence has helped us navigate great changes in our Presbytery and culture. During this same time, Russell has continued to wrestle with a life-long call to parish ministry, and over the past several years he has taken steps to pursue a call to become a Minister of Word and Sacrament. After being under the care of our presbytery's Committee on Preparation for Ministry (CPM) for several years, and having moved through the required steps of becoming first an Inquirer and then a Candidate, the CPM, in February of this year, certified that Russell had met all the requirements and was "ready to receive a call." The Council and Russell concluded that the May 31st end of his ministry with Savannah Presbytery would best allow Russell time and space to pursue his call and the Presbytery the chance to take necessary steps towards the future. We rejoice with Russell in this faith journey, and we look forward to what God has in store for him as he continues to follow Christ's call and claim on his life.

For information:

- Council appointed a nine-member Transition Team and approved a job description for the team. Team members are: Rev. Mary Beene (At-Large), Rev. Ben Beasley (Allenhurst), Elder Doty Dunn (First, Statesboro), Elder Grace Jones (First, Douglas), Elder All Mullice (Butler), Elder John Ricks (First, Eastman), Rev. Will Shelburne, Chair (First, Savannah), Rev. Deanie Strength (Skidaway Island), Elder Jean Vernon (First Brunswick) & Rev. Hampton Williams (Blackshear). The Team's primary goals are to guide the Presbytery and Council through the transition from a long-term General Presbyter/Stated Clerk/Treasurer, to interim leadership, and, ultimately, to new Presbytery leadership and a healthy, vibrant future. Additional details were sent out to the Presbytery in April.
- The Transition Team and Council will be aided by consultant, David York, an Elder from Greater Atlanta Presbytery. David has worked with our Presbytery in the past, and we trust he

will once again help us to better understand where the Presbytery is now and where God is leading us to go in the future.

- Council approved a minimum total salary package range for an interim general presbyter of \$90,000 and agreed that at this time, only persons outside of Savannah Presbytery would be considered for the interim position. Council also approved a job description.
- Council approved the formation of a Technology Team to consider how to best take advantage of a Synod of South Atlantic grant that is available but must be applied for by the end of the year. This Team will report back to the Council at its September meeting and make recommendations for action.
- The Finance and Stewardship Committee reported that an internal audit/financial review was completed on the 2018 Presbytery books.
- Rev. Jamil el-Shair was elected chair of the Presbytery's Nominating Committee and was tasked with reinvigorating both the Nominating Committee and nominating process for the Presbytery.
- Rev. Rick Douylliez was elected chair of the Presbytery's Personnel Committee.

Presbytery Transition Team Savannah Presbytery Job Description

SUMMARY

The Presbytery Transition Team, working closely with consultant David York, will help to ~~help~~ guide the Savannah Presbytery and Council through the transition from a long-time general presbyter/stated clerk/treasurer. This team will lead a celebration of the outgoing GP/stated clerk/treasurer, oversee the process of finding an interim GP/stated clerk/treasurer and/or Chief Administrative Officer to recommend to the Council, and lay the groundwork for calling/hiring new presbytery staff leadership who will help to lead the presbytery to a healthy and vibrant future.

ESSENTIAL RESPONSIBILITIES

- **Develop plans for the presbytery to celebrate** and give thanks for the ministry and service of outgoing GP/stated clerk/treasurer, Russell Gladding. Russell's last day of service to the presbytery is May 31, 2019.

- **Conduct search for an interim general presbyter** to begin service as soon as possible following Russell's departure. The Transition Team's recommendation must be approved by the Savannah Presbytery Council.
- **Oversee transition** of all administrative and logistical functions from outgoing GP/stated clerk/treasurer to interim hire and/or appropriate presbytery committees.
- **Work closely with interim** to consider and present to the Council a sustainable vision for the future ministry of the Savannah Presbytery. This may include examining recommendations of the 2020 Task Force with a particular emphasis on determining a model for staff to support functioning ministry teams and committees of presbyters better organized to carry out the presbytery's mission. Proposed updates to the Savannah Presbytery Operations Manual reflecting these changes would be in order.

TIME COMMITMENT

The Transition Team will begin its work as soon as possible in winter/spring 2019. The responsibilities of the team will conclude upon the hiring and successful transition to a permanent staff and ministry team model. Team members should expect to have regular meetings both in-person and virtually throughout the course of its work.

RELATIONSHIPS

The transition team reports directly to the Savannah Presbytery Council. This team will also work closely with consultant David York.

For Information:

Your Transition Team has been working extremely hard since our first meeting on March 26th. We have met almost weekly since then and have, with the 2020 Visioning Taskforce report, the Savannah Presbytery Operations Manual, and our job description in hand, organized today's celebration of the ministry of Russell Gladding, completed a Ministry Information Form (MIF) and a more extensive job description for the Interim General Presbyter/Stated Clerk position, developed a job description for the Interim Treasurer position, met with Liz Richardson concerning the transition, completed an exit interview with Russell, and worked with the Personnel, Nominating, and Stewardship & Finance committees to discern pressing needs in the short term and long term needs that will support the healthy functioning of our presbytery in the future. Our first meeting was spent sharing our appreciation for Russell Gladding's faithful ministry, our concerns moving forward after his departure, and discerning together the needs of Savannah Presbytery.

Interim General Presbyter/Stated Clerk: Working with both Synod Executive Joyce Lieberman and Consultant David York, the Transition Team developed a job description based on what we, as representatives from ten congregations and each of the three districts in Savannah Presbytery, perceive to be the presbytery's needs and desires for this position. Mary Beene put the document together and each team member provided feedback which was integrated into the description and then sent to both David and Joyce for their suggestions. Joyce encouraged us to use the more detailed document to draft a MIF which was completed in early May, was approved by Council, and is now ready to be posted on the PCUSA's Church Leadership Connection system.

Interim Treasurer: The TT was tasked with transitioning all three of Russell's "hats," which includes his work as Treasurer. The team felt strongly that this position should be separated from the other two in

order to give whomever is called to serve as IGP/SC ample time to carry out the many tasks required of these two roles. Because of the obvious overlap of hiring personnel, the TT appointed RE Doty Dunn to serve as a liaison to the Stewardship & Finance (S/F) Committee. Doty, Deanie Strength, and Will Shelburne met with Paul Scott to gain insight into what is required of the treasurer and how that position relates to S/F. Russell Gladding was also consulted about the duties of the job, an estimate of time needed to sufficiently carry them out, and possible compensation. Deanie Strength put together a job description using feedback from Russell, S/F, the Savannah Presbytery Operations Manual, and a treasurer description from Milwaukee Presbytery. The team has also considered *volunteer* treasurer models that have worked in other presbyteries and in the Synod of the South Atlantic. The TT used the same process as the IGP/SC position; seeking input from the team and together revising the job description to reach a consensus. The Transition Team hopes to have the job description ready and approved by Council by the May 21st stated meeting or shortly thereafter.

Next Steps: The Transition Team is finalizing the process by which they will receive Personal Information Forms (PIF) from interested candidates, evaluate the candidate's qualifications, experience, and congruency with the Presbytery's needs, and communicate with them. Once the search begins for the IGP/SC and Treasurer, the TT will begin exploring various staffing models for the presbytery, based upon perceived needs in the following areas: communications, technology, programming, secretarial, and financial.

In the meantime, Liz Richardson will continue in her position as Business Administrator at the presbytery office until the end of 2019. By that time, we will have progressed through some of the transition, possibly gaining an Interim General Presbyter/Stated Clerk as well as a better understanding of how best to carry out the administrative and financial operations of the presbytery. The Transition Team and the Personnel Committee are in continuing conversation with Liz about her plans and ours, and we appreciate her understanding as we consider staffing models. For a time, she will be the main point of contact at the office. If information is needed outside her scope of responsibility, she has been asked to refer questions to the appropriate leadership of the COM, Transition Team, Personnel, and other teams and committees. We hope that you will be patient and understanding during this time of transition.

Using the Operations Manual of SP, and in consultation with the Nominating Committee, the TT is also looking at the various committees/teams in the presbytery and how they relate to one another, to council, and to the GP/SC and office staff positions. Additionally, we are addressing whether or not these committee/teams are adequately staffed with volunteers. We have discovered that the requirements laid out in the operations manual will most likely need to be adjusted in terms of volunteers needed for each committee/team. We know for certain that the Nominating Committee will need to expand the pool of possible volunteers to serve on the presbytery's committees/teams.

David York will continue to work in consultation with the Transition Team and has expressed a willingness to be flexible as we discern how best to use his expertise in this process. The Transition Team has decided to hold "listening sessions" that will take place in all three districts of the presbytery, after the IGP/SC has arrived, so that he/she might have the opportunity to meet members of the presbytery and hear their concerns and hopes firsthand. David York will facilitate these sessions.

The Transition Team has quite a task ahead of us, so please keep us in your prayers as we seek to discern God's will for Savannah Presbytery. We assure you that we are working very intentionally and prayerfully to address the needs of the presbytery in this time of transition. We are thankful for the great leadership Russell has so faithfully provided us and are hopeful for the future that God has in store for us. Thank you all for entrusting us with this work.

The Presbytery as a whole is transitioning and so too are our programs, which require many hours of work to plan, organize, and execute. As we explore new ways to be a presbytery, we recognize that we are in need of visioning and some restructuring and reorganization of our programs to ensure that they

can be viable and enriching for years to come. In consultation with the Nominating Committee, the ETT is working to restructure itself by adding more members to serve in a visioning/planning capacity, while also working closely with appointed task forces that plan and execute summer camp/youth ministry, SOL, and FEC.
